- The right may be granted retroactively for a maximum of 6 months (cf. Kela).

The child's guardian fills in the application form and delivers it to the child's early childhood education provider. A person in charge at the child's early childhood education unit checks the application and forwards it to the service counselling of the Finnish Early Childhood Education of the City of Espoo at **P. O. Box 3125, 02070 City of Espoo**. If the form is incomplete, we will return it to the child's guardian.
